The Thompson Township Regular Board Meeting was called to order at 6:00pm by Theresa Lund, Supervisor and was followed by the Pledge of Allegiance. Roll call was taken by the Supervisor for Board Members present.

Approval of Agenda: Theresa Lund wanted to add FD grants, FD purchase policy, FD training and under unfinished business Cory Frankovich. Motion to accept the Agenda with the changes, was by Cathi LaBar, 2nd Sandra Houghton, Passed 4 Yea, 0 Nay.

Approval of Minutes: Motion to accept both minutes was by Martha Wnuk, 2nd by Sandra Houghton, Passed 4 Yea, 0 Nay.

Treasurer's Report: Motion to accept report as submitted by Cathi LaBar, 2nd Martha Wnuk, Passed 4 Yea, and 0 Nay.

Assessor's Report: Motion to accept report as submitted by Cathi LaBar, 2nd Martha Wnuk, Passed 4 Yea, and 0 Nay.

Fire Department Report: Marcus Cheruvront, Fire Chief, They had 1 runs last month. Delivery for the new fire truck should be the 1st week in May. There was a discussion on the grants that are applied for every year and that the board should be notified when and how much they will cost the township. Martha Wnuk made the motion to approve the fire department report and the 2010 grants, was 2nd by Sandra Houghton, Passed 4 Yea, and 0 Nay. The Fire department will be assisting with the State by burning the Thompson Plains. Marc Cheruvront and John Burke will be going to Wisconsin to help with what is going on the new fire truck and where to put all the equipment. Martha Wnuk made the motion to approve the FD to assist with the burn and them to go to Wisconsin, 2nd by Cathi LaBar, Passed 4 Yea, 0 Nay.

Historical Committee Report: Laurie Jasmin, said they are getting prices on roof materials for the Sacristy. They are also ordering more note cards made for the Christmas tree program. Adopt a Highway is set for April 25th at 11:00 a.m.

The fire department should have the new fire truck by then so the fire department will be there. Both boards will be having another meeting on what plans will be made for the picnic.
