**Board of Review Application** Theresa Lund received one application to replace Kate Steider on the Board of Review from Patrick Nelson. Motion made by Martha Wnuk to make Pat a second alternate to the Board of Review, 2<sup>nd</sup> by Cynthia McDaniel, Passed 5 Yea, 0 Nay.
